 Must have an experience of successful execution of tree transplantation activity in public sector/private sector organization of repute;

Own a high-tech tree transplanter;
 Or
 Have a tie-up with a reputed manufacturer of the high tech tree transplanter;

## Scope of Work

- a) Carry out a pre-transplantation study; prepare and submit a report highlighting the transplant-ability of trees; A detailed report from a competent entity highlighting the trees that can be transplanted based on the tree health should be shared;
- b) Depute / deploy required number of manpower for smooth operation and maintenance of the machine and carryout the required transplantation of Trees. The machine should be capable to finally transplant the trees in desired direction / orientation for survival. The deputed persons should be competent to carry out the transplantation job in the mannerratified by the said agency to ensure that the complete activity is under a prescribed process thereby enabling the adherence and survival of transplanted trees;
- c) Necessary insurance for the machine, man power during operation at the jobsite;
- d) In order to ensure high survival rate of the transplanted treesthe post-transplant care for a period of 03 monthshas to be done by the bidder.
- 3. RMC will assist for the following:
- a) All related permissions for the machine as well as manpower to carry out the job at the site.
- b) Permission to a portion of road for a pre-determined duration, in case tree is very close by roads.
- c) Permission to run the vehicles on public road when carrying the load i.e. tree because of the vehicle may not be within CMVR rules if trees are heavy or have large dimensions.
- d) Clearance for land from where tree is to be picked and final location to where it is to be transplanted.
- e) Creating routes for approaching the trees using means like JCBs wherever necessary.
- f) Earmark the trees allotted for transplant and permissions for the same from government agencies like forest departments etc...
- g) Provide necessary clearances in terms or underfoot conditions like overhead and underground cables, pipes, drains,

## 4. PAYMENT TERMS:

I) 70% on after transplantation of trees. Bills may be raised on minimum monthly progress basis.

II) Balance 30% on completion of 03 months/ 90 days after transplantation, based on joint inspection within further 15 days, and only if the survival rate of more than 70% is obtained.
