### TENDER FOR OUTSOURCING THE SERVICES OF TANKER WATER SUPPLY

Sealed tender are invited from licensed contractor registered firm/Agency for supply of water through tankers in RMC Area.

The duly filled in tender form should be submitted along with the following documents.

- 1) A non refundable Demand Draft for Rs. 5000/- towards Tender Fee
- 2) Demand Draft for Rs. 25000/- towards EMD.
- 3) Up-to-date GST registration & PAN card.
- 4) Photocopy of the Registration Certificate of the unit as Proprietorship / Partnership / Limited Company.
- 5) Photocopy of first page of Bank Account Passbook
- 6) Affidavit for non blacklisting in GOI/State Government/PSU.
- 7) Demand draft must be submitted in favour of Municipal Commissioner, RMC.
- 8) The undersigned reserves the right to cancel the tender at any stage without assigning any reason thereof.
- 9) The decision of Procurement committee will be final and no claim in any form will be entertained.
- 10) Enclosures list should be submitted with technical documents.

### 1. Scope of work

1.1 The supply of water on demand by water tanker to customers in RMC Area at a price /

fee fixed by RMC, Ranchi (Please refer Annex 1).

- 1.2 RMC will provide the tanker at its disposal. The contractor / agency has to pay hire charges against it, as mentioned in Annex - V. The Agency needs to submit a half yearly tanker hiring plan as per the format provided in Annex-I in advance before hiring the tanker of RMC along with hiring fees in the form of Demand Draft. If RMC fails to provide the tanker as per hiring plan, the agency may arrange it from external sources her taking NOC from RMC.
- 1.3 It is mandatory to hire the tankers of RMC at first priority





- 1.4 The water will be filled from the hydrants as per the list attached in Annex- V.
- 1.5 The Agency should be able to supply water a short notice way within 2 hours on any day including Holidays / Saturday/ Sunday. if he fails to deliver in time, RMC reserves its right to get the same through other agencies. All payments made to other agencies shall be adjusted from contractor firm balance payments / Security Deposit.
- 1.5. The tanker used for supplying water should be clean and in satisfactory hygienic condition.
- 1.6. It is the responsibility of the agency/firm /contractor that the tankers drivers shall strictly observe the traffic rules. If any accident, injuries or harm is sustained by the tankers all the claims, liabilities, compensation will be under the scope of agency.
- 1.7. The repair & maintenance of the tanker and transportation vehicle hired during the contract period will be carried by the agency/contractor.
- 1.8. The contractor/Agency will have to develop an online application including mobile apps, sms & email alerts for booking and other activities related to this service. They also have to provide a dashboard to RMC officials for monitoring the activities and generating the required MIS. The complete workflow, approach & methodology should be submitted along this bid RMC may provide the booking counter to the agency for offline booking depending on availability of space.
- 1.9. In summer (i.e March, April, May, June) RMC will provide limited numbers of tankers based on availability in daytime. However all the tankers are available for hire **between 8.00 pm to 4.00 am.**
- 1.10 The delivery fees of water per tanker will be as per Annex-V. Future it the rate enhanced then the MLF will also be enhanced proportionately.

#### 2. General Terms, Conditions & Information

- 2.1 The Contract / service will be valid for a period of three years.
- 2.2 The RMC will reserves the rights to forfeit the security deposit during the validity of contract if there is any breach of service / contract from the service provider viz, non supply of water in time, less quantity of water in tankers etc.
- 2.3 In case of delay supplying of water as per demand and any complaint received against the same, the penalty will be imposed by RMC.





2.5 RMC will reserve the right to terminate the contract / service by giving a notice of one month to the Service Provider, in case the service is found unsatisfactory or any other reason.

- 2.6 Tenure of the contract / service may be extended upon the mutually agreed terms and conditions between the service provider and RMC, if necessary.
- 2.7 The contractor should certify and affix his signature on each and every page of the tender documents and submit A along with his tender offer at RMC office.
- 2.8 Any tender with conditions other than those specified in the tender document is summarily rejected. No modification by the contractor in any of the conditions will be permitted after the tender is opened.
- 2.9 Consortium bids are allowed maximum up to two firms and one of the firms must be a reputed IT firms having the experience of three years in If software & services detects should be furnished in Annex 2 of both the parties. A consortium agreement for this bid must be submitted.
- 2.10 None of the firm ether individual or in consortium has been blacklisted by any of the govt. / Semi Govt. / PSUs department. (An affidavit for the same must be submitted along the bid)
- 2.11 The minimum reserved price for Monthly License Fee (MLF) is Rs. 30,000.00. The bidder has to quote monthly license fee exclusive all the taxes in prescribed format. The agency who proposed the highest MLF will be considered as H1 bidder.
- 2.12 RMC will provide parking space for tankers, hydrant for water filing, office space (based on availability) against the Monthly License Fees.
- 2.14 The successful bidder has to submit a performance guarantee of amount Rs.2.00 Lakhs in the form of Bank Guarantee after the award of work order. The agency also needs to deposit caution money, which is refundable after the completion of contract period, of amount 1.5 Lakhs in the form of Demand Draft to RMC.

### 2.15 Contract Violation:

(a) If the agency violets the fee as defined by RMC, an amount of Rs. 5000/ - per violation has been penalized by RMC.





- (b) If agency caught in any traffic violation then an amount of Rs. 2000/ violation has been penalized by RMC.
- (c) If found that the water in dirty during the supply, an amount of Rs. 2000/ per such guilty has been penalized by RMC.
- (d) If the agency failed to maintain the tanker provided by the RMC then a penalty of Rs. 5000/ per Incident will be imposed.
- (e) If the agency found tardy in service delivery & quality at any point of time then a penalty of Rs. 1000/ per incident will be imposed.

Incase of no- payment of penalty charges, the same amount will be deducted from the caution money.


