



3. Agreement with bidders selected through **e-procurement** shall be eventually draw in PWD From no-F2

4. The work shall be completed in all respect in within the period given as above after AOC (Award of Contract). The item of work, plan specifications or any information in connection with the work can be seen in the office of the Chief Engineer, R.M.C, Ranchi On any working day during office hours before submitting bid.

5. Cost of tender/bidding document in the shape of demand draft issued by any Nationalized Bank, in favour of Municipal Commissioner Payable at R.M.C, Ranchi and cost of **earnest money** in the shape of Bank guarantee in prescribed Performa as per annexure-1 from any Scheduled public sector bank and valid for 180 (One hundred and Eighty) days from the date of receipt of tender or 6 ½ year National Saving Certificate (6th issue & 8th issue) or 3/5 Years Post office Time Deposit duly pledged from and Post Office within the state of Jharkhand, in favour of Municipal Commissioner, R.M.C, Ranchi shall be deposited in the office of the Superintending Engineer, R.M.C, Ranchi on all working days between **20/11/2015 To 26/11/2015** upto 3.00 P.M. either by registered post/Speed post or by hand. Only those applications will be entertained whose cost of tender paper and earnest money is received before 05.00 P.M. on **27/11/2015**. R.M.C. will not be responsible for the postal delay, if any, in the delivery of the document or non receipt of the same. Insurance Guarantee Bond/Cash/cheque/Bank Draft in place of those specified for EMD shall not be accepted. Cost of tender documents will be non-refundable.
- 5.1 Duly pledged Earnest Money, if any, lying with the concerned Municipal Commissioner, R.M.C, Ranchi work already completed shall not be adjusted by transfer. In such case the tenderer is required to get the same refunded/released and then attach the same with the tender, duly pledged afresh for the work for the which tender is filled.
- 5.2 Tender not accompanied with required Earnest Money in the prescribed manner shall be rejected outright and will not be evaluated.
- 5.3 Clauses 5.1 to 5.2 shall not apply to tender (s) who are exempted from depositing E.M. but such tender(s) must enclose Photostat copy of the exemption certificate issued by the competent authority in this respect.
6. In case the overall rates quoted by the tender/bidder is more than 10 (Ten) % below of BOQ rates on overall items, this shall be treated as un-workable & the tender shall be treated as invalid tender.
7. It will be obligatory on the part of the tenderer to keep their offer open for acceptance for a period of 180 days from the date of opening of the tender.
8. Tenderer (s) shall enclose scanned copy of his/his/her/their registration & exemption certificate (if any) in absence of which the tender (s) may not be considered.
9. Sales Tax/income Tax clearance certificate, character certificate & letter of Registration as contractor shall be submitted by the tenderer or otherwise it may be rejected.
10. Authority reserved the right to reject any or all the tender (s) received without assigning any reasons thereof.
11. In the case of successful tenderer (here in after called contractor) the amount of E.M. will be transferred towards initial security Deposit in such a manner so that the security deposit will form part of 5% of the approved amount of the approved tender & the remaining 5% shall be recoverable from the subsequent bills of the contractor.
12. The **Earnest Money (E.M)** of the successful tenderer (hereinafter called the contractor) which accompany the tender will be forfeited in case the tenderer declines to sign the agreement or fails to deposit Security Money within 10 days of being called upon to do so. Those contractors, who are exempted from depositing E.M. will deposit initial security money within days of being called upon to do so. If they fail to do so or decline to sign the agreement within the stipulated period, the requisite sum of money will be forfeited by way of adjustment from any sum to be paid to him by the department for other works, including his security money and in addition he may be Black Listed and subsequently his registration may be cancelled.

13. The N.I.T. along with general rules, condition of contract and special conditions of contract copies of which are available on the website –<http://jharkhandtenders.gov.in> will form part of the contract Document.
14. It is essential for the tenderer (s) to have ownership of the following Machineries in working condition :-
 - (i) Mixture Machine
 - (II) Needle Vibrator / Plat Vibrator
15. It is essential for the tenderer (s) to submit Experience certificate of Similar nature of work of Value minimum Equivalent to tendered work value.
16. Tenderer (s) are required to attach with their tenders authorized and valid certificates regarding their actual ownership of the machineries and Experience certificate mentioned in clause 14 & 15 above, failing which their claim for allotment of the work may be rejected.
16. Valid certificated of actual ownership of the above mentioned machineries attached with the tenders must prove that the tendere/tendere (s) himself// themselves are actual bonfire owners of those machineries and the same are in working condition.
17. Payment against works will be made subject to availability of fund.
