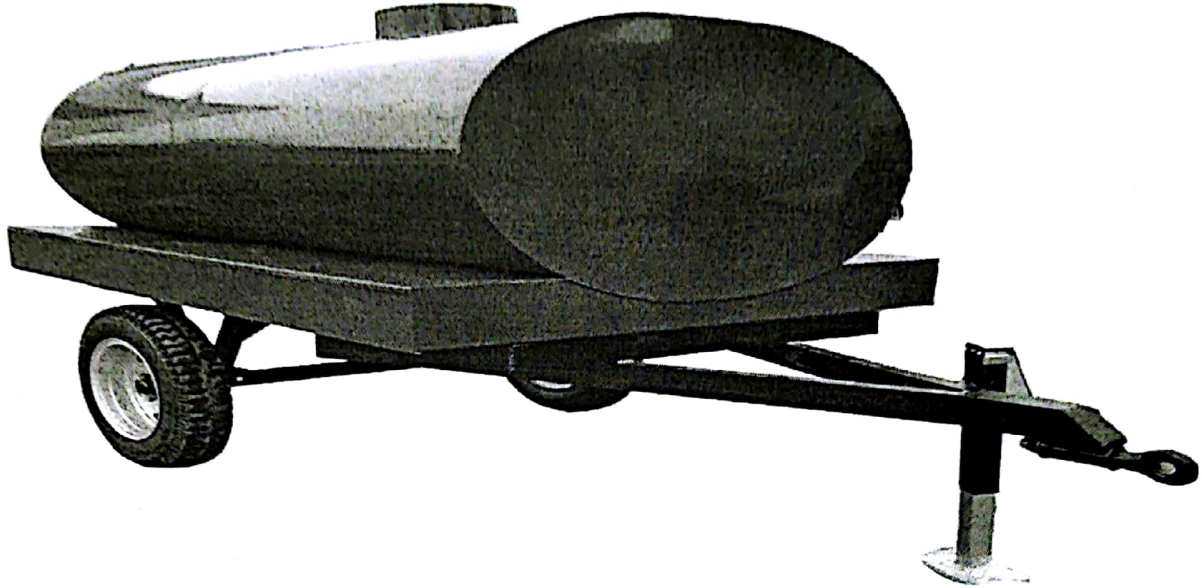

Tender Document for supply and Maintenance of water tanker at Ranchi.

SCOPE OF WORKS:

1. The bidder has to supply 4kl water tanker / Repair Work of water tanker for four year against any manufacturing defects.
2. Bidder has to keep his own work force for supply/Repair and Maintenance work.
3. Bidders have to supply & maintain the water tanker for four year on his own cost.
4. A successful bidder should deposit security Rs 50,000/-demand draft in favour of municipal commissioner , ranchi municipal corporation ranchi

TECHNICAL SPECIFICATION:

1. A Water tanker should Made up 05 MM Mild Steel Sheet.
2. A Water tanker frame should Channel Iron 5" x 2.5". Angle Iron 35x35x5mm.
3. A Water tanker should have Heavy Duty Tyre, Hub & Rim size 9.20 (Branded Tyre),with differential 1210 front.
4. 2HP Water pump set (Branded Company only) with suction and delivery pipe (7 ft & 28 ft) respectively, with two tape and one drain valve socket (with one time warranty) at back side of the tank and proper hooking arrangement.
5. A water tanker should be painted by zinc primer inside the tank and the tank will be painted with first quality double coated Branded paint only.

FINANCIAL TERMS:

1. The bidder must have annual turnover of Rs. 25.00 lakhs in any year during last three (3) years.
2. The bidder will have to give the financial quote (Per unit price including GST) of the Financial Bid as per Annexure I.
3. For supply and maintenance works of water tanker, the cost should be fixed
4. The bid cost shall be Rs. 5,000/= (Rupees five Thousand only) in form of Bank Draft and it should be made in favour of **Municipal Commissioner, RMC** payable at Ranchi. This is non- refundable.
5. EMD of Rs. 25,000/= (Rupees twenty Five thousand only) as demand draft in favour of **Municipal Commissioner, RMC** payable at Ranchi shall also accompany the Technical Bid.
6. Within 20 days of receipt of the Letter of Acceptance, the successful Bidder shall supply water tanker. Successive supply to be maintained otherwise security deposit will be forfeited.

BID SYSTEM:

1. This shall be one bid systems: Technical Bid and Financial Bid.
2. Bidders have to quote The Rate for supply of water tanker and Maintenance as Per Annexure I
3. The bidders have to submit the proposal with proper page no.
4. The Bidders have to quote the rate for supply of water tanker (Repair and New installation) with four year maintenance which will form the total Rate for Financial Bid

BID DISPOSAL:

1. After the technical evaluation, the bidders who are found non-responsive in the technical bid. The financial bid would not be entertained.
2. Final Bid shall be evaluated on following basis of the Financial Bid.
3. Bidders who quotes the minimum Rate L₁ in the financial bid shall be awarded the contract .





OTHER CONDITIONS:

1. Upto date GST return, PAN card, 2018-19 ITR certificate (AY).
2. A bidder should have authorization certificate of manufacture /small industries. Registration certificate in case of self manufacturer, preference will be given to ranchi based unit.
3. Affidavit for non blacklisting in GOI/state Government /PSU.
4. Except successful bidder the EMD of rest bidders will be refunded after complete supply by successful bidder.
5. The undersigned reserves the right to cancel the tender at any stage without assigning any reason thereof.
6. In case of any inquiry bidders may visit the office of the undersigned in office hours (10 am-5pm).
7. The decision of the procurement committee will be final and no claim in any form will be entertained.
8. The R.M.C reserves the right to reject any or all the tenders without assigning any reason whatsoever and no conditional will be accepted.

PAYMENT SCHEDULE:

1. No advance shall be given.

NEGOTIATION

1. If it is felt that the price quoted by the lowest tenderer is exorbitantly high with reference to the prevailing market rate, negotiation of rates will be made with the lowest tenderer for reducing the quoted rates. If the tender contains unbalanced items/rates the lowest tenderer must be prepared to furnish the detailed cost break up and other clarifications to the proposals submitted by them, as may be required to adjudicate the reasonableness of their price proposals.
