

A. Scope of Work

The scope of work for the agency shall be as indicated below -

1. Supply, installation and Maintenance of tri color (saffron, white and green) rope lights in Electric poles specified by RMC under Ranchi municipal area.
2. Providing electrification connection to all rope lights (three in one pole) with the street lights panel with dedicated overhead cabling adjoining the poles, where required.
3. The rope lights should be wrapped around the poles from the top to the bottom leaving only 2 feet from the ground.
4. The selected firm will have to maintain the rope lights for a span of one year after the date of completion.
5. The agency/firm will be liable for any kind of replacement either due to non performance of the rope light or any robbery taking place during the tenure of agreement.

A. GENERAL TERMS & CONDITIONS AND ELIGIBILITY CRITERIA

- i) The sealed packets of tender fee and EMD should reach and be delivered in the office within the stipulated date and time positively. The department will not be held responsible for any delay or loss or damage of the DD/BG etc. during transit and in such event the bid would stand rejected summarily. The sealed cover shall be received in the office of Light Section, Ranchi Municipal Corporation.
- ii) The tender should be uploaded in two bids i.e. :
 - a: Technical Bid document.
 - b: Price Bid. There should be proper indication of the contents as mentioned in annexure 2.
- iii) The **Technical bid** should contain the following:
 - a) Affidavit regarding non blacklisting by any govt/PSU.
 - b) Documents showing GSTIN, PAN and ESIC registration.
 - c) Details of tender fee and EMD.
 - d) Audited annual balance sheet of last 03 (three) years in support of turnover.
 - e) Mention the technical details in Annexure 01 also.
 - f) Document related to trade license for work must be provided.
 - g) First the technical bid will be opened. Those who will qualify in the technical bid will be intended for demonstration of their work. Financial proposal of only those bidder will be opened whose demonstration get approved by RMC authority.
- iv) **Commercial bid**
 - a) The commercial bid will be opened only for those bidder who would qualify in the technical bid and are selected after demonstration. The lowest rate (L1) will be decided on the basis of the total quoted amount.
 - b) Rate must be quoted in a attached format provided in Annexure 02.
 - c) Prices/rates should be inclusive of all taxes and charges. RMC shall not provide /not bear cost of or any additional items.
 - d) After the technical evaluation of the bidders, financial bid of only those bidders will be opened who get successfully qualified in the technical bid.
 - e) Final Bid shall be evaluated on following basis :-
Total Financial Bid = Part 'A' + 'B' of the Financial Bid.
 - f) Bidders who quotes the minimum total in the financial bid shall be awarded the contract for one years.
- v) Any bid received by the Tendering Authority after the deadline for submission of bids prescribed by the Tendering Authority, will be rejected and/or returned unopened to the Bidder

- vi) The bidder shall be a proprietor, registered firm or any company, authorized dealer.
- vii) Bidders shall have a team of experienced personal who possess good knowledge / Experience of the electrification work on electric pole and are capable of installation of rope light on them.
- viii) The Bidder should have annual financial turnover during any of the last three years (2018-19, 2019-20 and 2020-21) not less than Rs. 2 Crore.
- ix) RMC reserves the right to undertake confidential verification of the bid documents received. Discrepancies found, if any, will be deal as per the law.
- x) Rates/Prices to be quoted should be inclusive of all taxes, freight, insurance, charges, etc. Each quantum of payment to be made by RMC to the agency shall be subject to statutory deductions/retention as per relevant practices and rules.
- xi) The Bidder must have Green Electrical License with validity (*Attach certificate*).
- xii) Tender shall be written in English and the proposal and all the associated documents will be submitted either in English or Hindi language. Documents in other language will not be considered unless and until it's translated version is not submitted with it.
- xiii) The firm should submit valid GST Clearance certificate from the competent authority along with the tender paper.
- xiv) The Municipal Commissioner reserves the right to reject any or all of the tenders without assigning any reasons.
- xv) The successful tenderer shall furnish a performance bank guarantee (BG) of 5% of entire value of every work order.
In case of successful bidder EMD shall be converted and adjusted against the security deposit and for unsuccessful bidder the EMD shall be returned after award of the work to the successful bidder.
- xvi) Site Inspection: Bidder(s) are deemed to have got acquainted with the site conditions and also advised to visit the site sufficiently in advance of the date fixed for submission of tender.
- xvii) Before tendering, the bidder shall visit all sites and satisfy himself to the prevalent conditions and quote accordingly.
- xviii) Bidder should have at least one office of their own having their own engineers/technicians in Ranchi.
- xix) Bidder shall have to maintain the rope light for one year after successful installation.

- xx) Bidder should visit site initially and acquaint himself with relevant location, condition, and type of pole before quoting rate.
- xxi) The bidder must have the experience of work related to electric pole.
- xxii) List of road and number of poles where rope light will be installed in electric pole is mentioned in Annexure-03. Numbers of poles may increase or decrease and payment will be made on actual work done or actual no.s of rope light installed on pole.

f) PAYMENT TERMS :

40% of payment will be made after successful installation and verification by RMC. The remaining 60% will be paid in 12(twelve) equal parts on monthly basis. The payment for each month will be paid in the first week of the successive month.

g) PENALTY

A penalty of 2% of the quoted rate will be imposed for failure to respond during maintenance work.

h) LEGAL DISPUTE AND JURISDICTION OF COURTS

In case any claim, dispute or difference arising in respect of the contract, the cause of action there of shall be deemed to have arisen in Ranchi and all legal proceedings in respect of any such claim, dispute or difference shall be dealt with amicably between the two parties or settled at Ranchi Court Only.
